CHARGES

I have received on this date \$ _____ as payment toward the above dog's boarding and/or training. The owner represents that he/she is the legal owner of the dog, and that the dog has not been exposed to any communicable diseases.

I agree to exercise due and reasonable care to keep my kennel premises sanitary and properly enclosed. The named dog is to be housed in clean, safe quarters. All dogs are boarded or trained, or otherwise cared for by Route 66 Dog Ranch, LLC, Stefanie Lorbiecki, and/or her employees or authorized agents without liability on behalf of Route 66 Dog Ranch, LLC, Stefanie Lorbiecki, her employees or agents, for loss or damage from disease, death, running away, theft, fire, injury to person, other dogs, or property by the dog, or other unavoidable causes, in excess of \$50.00 (fifty dollars).

The dog is not to be taken off the premises of Route 66 Dog Ranch, LLC without the express consent of the owner. The owner hereby, expressly, permits Route 66 Dog Ranch, LLC, Stefanie Lorbiecki, and authorized employees/agents to transport the dog(s) to any area selected for training and/or health purposes. I give Route 66 Dog Ranch, LLC, and/or Stefanie Lorbiecki, her employees, or agents, permission to take pictures or video of my dog(s) for commercial use.

Should the dog become ill, the owner shall be notified at once. If the owner cannot be reached, or does not inform Route 66 Dog Ranch, LLC immediately regarding measures to be taken, or if the dog's health reasonably demands quick action, Route 66 Dog Ranch, LLC, Stefanie Lorbiecki, and authorized employees/agents shall have the right to take the dog to a veterinarian, and have the veterinarian treat my dog(s) for said illness or injury. The owner shall reimburse Route 66 Dog Ranch, LLC for veterinary expenses on the same day the dogs depart Route 66 Dog Ranch for boarding or training.

If a dog is not called for within ten (10) days after time for retrieval of the dog, the dog will be removed from the boarding facility and shall become the property of Route 66 Dog Ranch, LLC. If the dog is to be sold, notice in writing of such intended sale shall be mailed by registered mail to the owner of the dog at the address given hereon, not less than ten (10) days before date of the intended sale, and no further notice shall be deemed necessary. Any excess amount over charges will be given to the owner; and any deficiency shall be paid by the owner.

When the above-named dog is released to the owner, it is further understood that the owner agrees to be **FULLY LIABLE** and to **INDEMNIFY** and **HOLD HARMLESS** Route 66 Dog Ranch, LLC, Stefanie Lorbiecki, or her employees, officers, directors, and agents for his/her actions and the actions of his/her dog while on or off the premises of Route 66 Dog Ranch, LLC.
